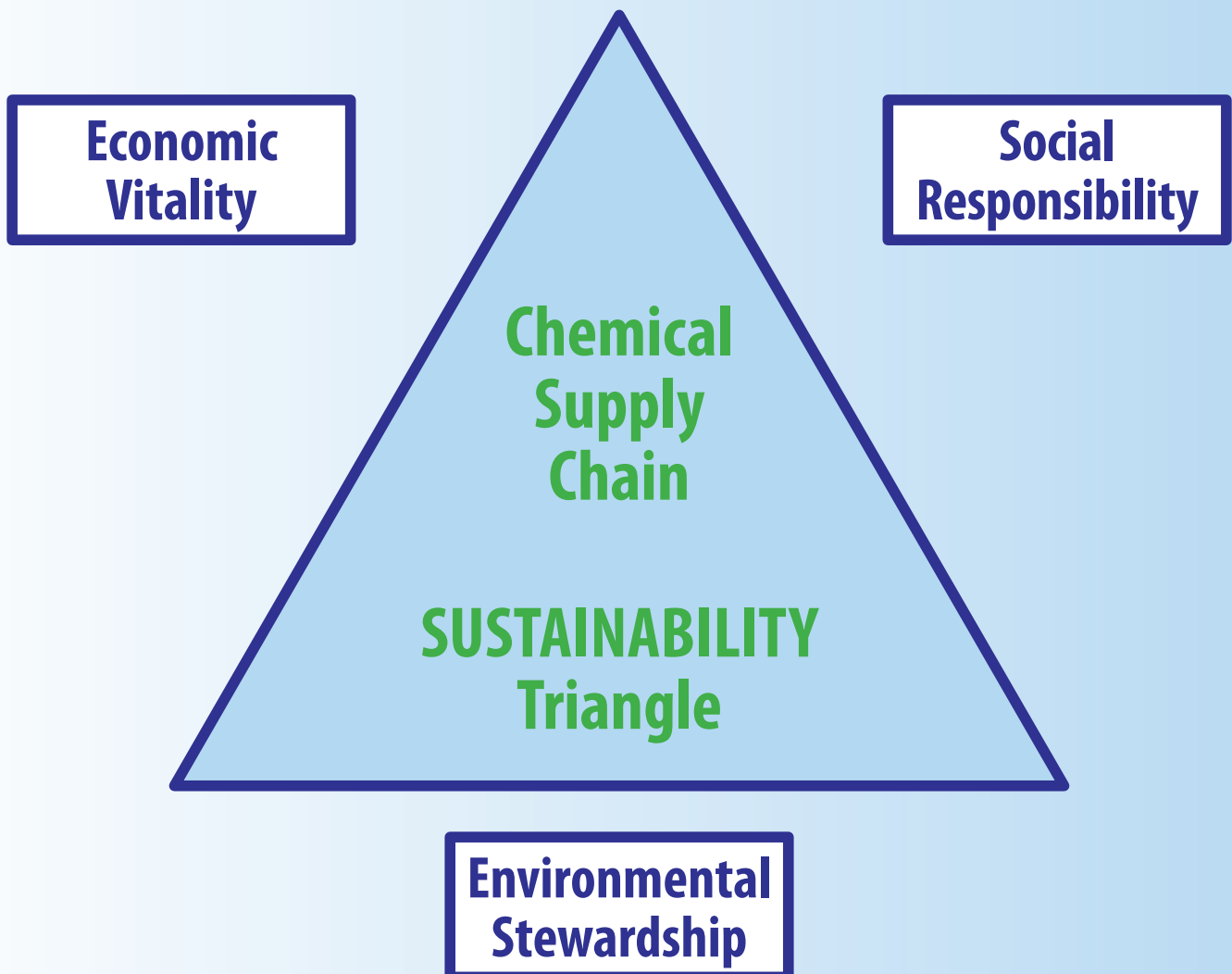


Why Bulk Liquid Terminal Companies should Participate in the CDI-Terminal Inspection Scheme (CDI-T)
